



## CONSUMER CONSENT

**Cross border transfer:** You agree that we may transfer your personal information to any country outside of South Africa where such country's data privacy laws are equivalent to or stricter than POPIA, or where we have concluded suitable agreements with third parties which comply with the relevant provisions of POPIA allowing for the processing of personal information;
